## 2006 Muskie Tournament September 8, 9, 10

**M**ake plans now to fish in the 39th Annual Frank Schneider, Jr. Memorial Muskie Tournament taking place September 8, 9 and 10 in the Walker-Bemidji-Cass-Winnie-Longville area in northern Minnesota. The Grand Prize is a Ranger 618T Fisherman, with a 90 hp Mercury motor. Any contestant who registers a muskie 40 inches or longer during the tournament will have their name included in the grand prize drawing.

Participating in the tournament is an excellent way to support our chapter and get in a lot of muskie fishing. It is always a great time. Tournament hours start at 7:00 am Friday morning and continue through Sunday. Twenty-one lakes in the area are open to fishing. On Sunday a Banquet and Awards Ceremony will be held in Walker City Park. The Sunday event includes a great burger and brat meal, door prizes for all contestants, and a tournament-only raffle. Tournament winners will be announced and the event will end with the Grand Prize drawing.

Individual adult tickets are \$70.00, juniors \$30.00 and they can be purchased in person through Labor Day at Thorne Bros. and Joe's Sporting Goods in the Twin Cities or at Reed's in Walker and Baxter/Brainerd and at Jerry's One Stop in Longville. Tickets will also be sold on Thursday, September 7 until 9:00 pm at Reed's in Walker and The One Stop in Longville.

This is an individual, not a team tournament. Prizes are awarded on a point system similar to our Members Only contest and include rods and reels, fishing tackle, a ton of other fishing stuff as well as fishing trips to Red Wing Lodge on Lake of the Woods; Huddle's Resort, Spirit of the North Resort, and New Leech Lake Campground on Leech Lake; Sunset Cove Resort and Sah-Kah-Tay Resort on Cass Lake; Vermilion Dam Lodge on Lake Vermilion; or Pine Beach Resort on Lake Garfield.

Bonus prizes include a total of \$1000 given to the top three female anglers in the memory of Mary Villnow, and bonuses from Abu Garcia and Lindy-M/G-Beckman for top muskies caught using their products. Details will be in each tournament packet.

The tournament-only raffle prizes include a trip to Trail's End Lodge, Clearwater/Pipestone chain in Ontario; a MinnKota trolling motor; MarCum Technologies fish finder; underwater viewing system; full-day Leech Lake guide trip with Dan Craven; and baits from Basin bait, Big Woody, Phantom, and TrueGlide.

Participating in the tournament is an excellent way to support our chapter and get in a lot of muskie fishing. We hope to see you there. It is always a great time.

# 2006 Chapter Challenge

This year our Twin Cities Chapter fielded three teams, some 14 anglers, for the Chapter Challenge on Lake Mille Lacs. The three-day event was put on by the Fargo-Moorhead chapter on Lake Mille Lacs from 9 – 11 August with 15 teams and 70 fishermen participating. The weather ranged from dead calm to 5 foot waves – the Big Lake showed us many of its moods.

How did we do? Well we did not win, again. Indeed we only got 2 Muskies for the three days of efforts. Dave Weyland got a 41-incher, John Newman got a 44 incher, and that was it. We did get some big Northerns, but they don't count.

The winning team from the First Wisconsin Chapter took home the Lunge Bucket. They beat out the field by bringing in six fish ranging in size from 43.5 to 49 inches. A total of twenty-three fish were caught, with seven at 50 inches or better, including one 55 inch giant caught by Jason Hammernick from North Metro.

The final standings:

1st. First Wisconsin-121 points.

2nd. North Metro Team #2-94 points.

3rd. Brainerd Team #2-77 points.

4th. Fargo-Moorhead Team #1-50 points.

5th. North Metro Team #1-41 points.

6th. Fargo-Moorhead Team #2 and Fargo-Moorhead Team #4-both with 24 points.

8th. Twin Cities Team #1-18 points.

9th. Twin Cities Team #2-15 points

So next year the First Wisconsin team will choose the location, and without a doubt our chapter will do better. It's a fun event, one of the many great things that Muskies Inc. and our chapter offer, and you should go!
