RELEASE OF LIABILITY – PLEASE READ BEFORE SIGNING

I expressly assume all risks associated with this tournament and I hereby release Muskies, Inc International and the Twin Cities Chapter of Muskies Inc., the host, sponsors, and tournament officials from all claims of negligence resulting from injury and/or property damage incurred in connection with the tournament.
2. I knowingly and freely assume all risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my participation; and
3. I will comply with all the rules and regulations. If I have a question, or observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest official; and
4. I, for myself and on the behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify and hold harmless the Muskies Inc, International and the Twin Cities Chapter of Muskies Inc, the owners and lessors of premises used to conduct the tournament, their officers, officials ("Releasees") with respect to any injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the Releasees or otherwise, to the fullest extent permitted by law.
